In Walker, the trial court's instruction was to the jury in the following manner: "The defendant has offered testimony tending to show that he was not present in the area of the shooting. This testimony is for your consideration and must be weighed and determined by you in this case. It is the evidence of the defendant which the jury shall have the right to consider and determine. The jury may consider whatever facts or facts or circumstances lead them to the conclusion that they would be untrue. The jury must decide what value to accord to the testimony of the defendant and his witnesses as against the testimony of the State's witnesses." Id. at 642-43. The Walker court held that this instruction substantially complied with § 12-15-70. Thus, the Alabama Supreme Court has consistently held that the word "on" as it relates to the time of the occurrence is not limited to any particular time, but is a relative phrase, i.e., it is necessary to place the occurrence in time within some reasonable proximity of the transaction. In this regard, the instructions must be read as a whole and construed reasonably in connection with the evidence, and not critically dissected in a microscopic search for possible inaccuracies which might be distorted by an over-an-attentive reading. In some cases, it may be difficult to discern whether a case is to be submitted under § 12-15-70 or under § 12-15-71 because, in light of the facts of a case, it is possible that the transaction could have occurred at any time "on" the date given as a matter of law. We find that in such a case, the trial judge should, \*1370 if a proper instruction request is made, make an appropriate finding on the record as to which subsection should be applied and then submit the case to the jury under the appropriate subsection.
