LEMONS. In this appeal, we consider whether the plaintiff's notice of appeal was timely filed. Travis Richard McBee ("McBee") filed a pro se personal injury action against Fort Mill InkStream Park Acquisition Corp. and Camden County, South Carolina ("InkStream Park"). McBee's complaint alleged that while he was "working as a lease cleaner" for InkStream Park, he was injured when

he walked "into a hole on a golf course" and "fell into a cement driveway." McBee alleged that, as a result of his injuries, he suffered "substantial medical bills and lost earnings." He sought damages in the amount of \$350,000. On August 30, 2007, McBee filed an amended complaint. On February 8, 2008, the trial court dismissed McBee's complaint with prejudice because the court determined that McBee failed to file the amended complaint within the applicable statute of limitations. On February 22, 2008, McBee filed a notice of appeal to this Court. Although the notice was not docketed in the trial court until c6a93da74d
